Dear Ms. Dortch:

Pursuant to the requirements of the standing Force Majeure Waiver,<sup>1</sup> AT&T hereby submits this Public Notices of Copper Retirement Under Rule 51.333 (**ATT20181015C.2**). On August 1, 2018, AT&T declared a Force Majeure in the state of California because of the Carr Wildfire, along with the cumulative effects of previous fires and floods in and around Redding, California.

On July 28, 2018, Governor Edmund G. Brown, Jr. of California issued emergency proclamations for Riverside and Shasta counties due to the effects of the Cranston and Carr fires. On that same day, President Donald J. Trump also issued declared that an emergency exists in the State of California and ordered Federal assistance to supplement State, tribal, and local response efforts due to the emergency conditions resulting from the Carr Wildfire.

The California Department of Forestry and Fire Protection (CAL FIRE) reported the Carr fire destroyed 1,079 residences, 22 commercial structures, 503 outbuildings and damaged 190 residences, 26 commercial structures, and 61 outbuildings.

<sup>1</sup> In the event of disasters that prompt the triggering of a disaster recovery plan, the Commission granted AT&T a limited waiver (of up to 180 days) of the advanced notification and waiting period requirements contained in its network disclosure rules (47 C.F.R. § 51.325-335), permitting affected carriers to concentrate on restoration efforts and execution of disaster recovery plans. See Petition of BellSouth Corporation for Special Temporary Authority and Waiver to Support Disaster Planning and Response, Order 21 FCC Rcd 6518 (2006) ("Force Majeure Waiver"). This waiver became operative when AT&T invoked declared on August 1, 2018.

### **Description of Network Changes Planned:**

**Pacific Bell Telephone Company d/b/a AT&T California**, is providing notice that it is retiring metallic copper feeder facilities to specific distribution areas due to the Carr Wild Fire that destroyed telephone facilities beyond repair in a portion of Redding Main Wire Center. (RDNGCA02, 1683 Pine St., Redding, CA 96001). Because the RDNGCA02 wire center is FTTP (fiber to the premise) enabled, copper facilities can be removed and replaced with fiber-based infrastructure without the prolonged build time usually required to upgrade a central office.

This action will require the retirement of copper distribution plant and service wires (Drops) in DA's: 421150, 421250, 421357, 421650, 440150, 440557, 460150 and a portion of 412750. AT&T California has a Gigabit Passive Optical Network (GPON)/Fiber to the Premises (FTTP) platform available to serve the impacted addresses in the embedded document below.

### **Description of Reasonably Foreseeable Impact of the Planned Changes:**

After the retirement of the DLC, SAI and ATM-DSL copper facilities, AT&T California will: (1) no longer offer services over the copper facilities; and (2) cease maintaining the copper facilities. Since the ATM-DSL platform is a copper-based architecture, the copper distribution plant and copper service wires (Drops) will be replaced with new fiber service wires to the NID. There are presently 891 living units in these distribution areas that will be affected with this transition from copper to an all FTTP network. There are no known CLEC circuits impacted by this project. The impacted addresses are in the embedded document.
