United Video, Inc., by its attorneys and pursuant to Section 1.1206(a)(2) of the Commission's rules, hereby submits an original and one copy of this memorandum regarding a permitted ex parte presentation to the Commission's staff regarding MM Docket No. 92-265.

On Friday, February 26, 1993, Jeff Treeman, President of United Video, Inc. and John Seiver and Wes Heppler of Cole, Raywid and Braverman met with Robert E. Branson, Senior Legal Advisor to Commissioner Andrew Barrett and then separately met with William Johnson, Alexandra Wilson, Bruce Romano, James Coltharp and Diane Hofbauer of the Commission's staff. The discussion related to United Video, Inc.'s comments and reply comments filed in response to the Notice of Proposed Rule Making in MM Docket No. 92-265, FCC 92-543 (rel. Dec. 24, 1992), which sought comment on the implementation of Sections 12 and 19 of the Cable Television Consumer Protection and Competition Act of 1992. Those provisions deal with the development of competition and diversity in video programming distribution and carriage.
