
Dear Ms. Dortch:

Pursuant to 47 C.F.R. §63.24(e)(4), this notice is to inform the Commission that, on November 20, 2018, consummation occurred of the transfer of control of Westphalia Telephone Company ("WTC") and Westphalia Broadband, Inc. ("WBI") to Chapin Communications Corporation.

On July 18, 2018, the Commission granted the transfer of control of the domestic authorizations held by WTC and WBI. *See* Public Notice, WC Docket Nos. 17-101, *et seq.*, DA 18-742, released July 18, 2018.
