JSI hereby provides notice on behalf of Sledge Telephone Company (“Sledge”) pursuant to Section 64.1120(e) of the Commission’s rules of an upcoming *pro forma* intra-corporate reorganization affecting Sledge Telephone Company and its affiliate, Lakeside Telephone Company, Inc. (“Lakeside”). Specifically, Lakeside will be merged into Sledge, and the telephone exchange customer base of Lakeside will be transferred to Sledge. 
