Garden Valley Telephone Company hereby provides notice that it intends to cease offering broadband internet transmission service as a separate component of its broadband internet access service and Consumer Broadband-Only Loop (CBOL) service Effective January 1, 2020. Garden Valley Telephone Company will only provide the transmission component as part of the complete broadband internet access service pursuant to the Federal Communications Commission's Wireline Broadband Order.¹ The geographic areas affected are Garden Valley Telephone Company Study Area 361395.

Today, the broadband internet transmission service is provided to Garden Valley Telephone Company's nonregulated ISP. As stated in the attached customer notice, Garden Valley Telephone Company will only provide the transmission component as part of the complete broadband internet access service via private carriage effective January 1, 2020.
