Red River Rural Telephone Association dba Red River Communications hereby provides notice that it intends to cease offering broadband internet transmission service as a separate component of its broadband internet access service and and Consumer Broadband-Only Loop (CBOL) service Effective January 1, 2020. Red River Rural Telephone Association will only provide the transmission component as part of the complete broadband internet access service pursuant to the Federal Communications Commission's Wireline Broadband Order.¹ The geographic areas affected are Red River Rural Telephone Association Study Area 381631.

Today, the broadband internet transmission service is provided to Red River Rural Telephone Association's nonregulated ISP. As stated in the attached customer notice, Red River Rural Telephone Association will only provide the transmission component as part of the complete broadband internet access service via private carriage effective January 1, 2020.
