Griggs County Telephone Company hereby provides notice that it intends to cease offering broadband internet transmission service as a separate component of its broadband internet access service and Consumer Broadband-Only Loop (CBOL) service Effective January 1, 2020. Griggs County Telephone will only provide the transmission component as part of the complete broadband internet access service pursuant to the Federal Communications Commission's Wireline Broadband Order.¹ The geographic areas affected are Griggs County Telephone Study Area 381615.

Today, the broadband internet transmission service is provided to Griggs County Telephone's nonregulated ISP. As stated in the attached customer notice, Griggs County Telephone will only provide the transmission component as part of the complete broadband internet access service via private carriage effective January 1, 2020.
