We are requesting a waiver of 47 C.F.R. § 54.719(b) 60 day rule due date on the decision letter being appealed. The district had filed a Form 500 to correct an erroneous contract expiration date on the initial filing. They also changed the amount on the Form 500. USAC approved the Form 500, but later filed another Form 500 on behalf of the school. This form stated it “reflects the corrected funding amount”. Believing this was just impacting the amount, we did not realize the contract expiration date had been changed back to the incorrect date on the initial application. We did not understand that the date had been reversed until it was past the initial 60 day window to file an appeal. USAC had to setup access for us to file an appeal, as we had never filed an appeal before as a service provider. We filed the appeal immediately upon discovery; however, we missed this deadline by only 5 (five) days. The timeline below is provided for reference of the documents enclosed.

In summary, we are requesting relief from the 60 day window so we can appeal the reversal of the initial Form 500 and get the correct contract expiration date of 6/30/19 submitted for the district.

## Timeline

- School Received Original FCDL 4/21/18 Wave 2, the school’s original application had a ministerial error, the wrong expiration date of 7/1/18
- School Filed Form 500 on 3/21/19 to correct Expiration Date 7/1/18 to 6/30/19
- Appeal approved and Revised FCDL issued 4/3/19 Wave 22 with new contract expiration date 6/30/19
- USAC did a review and issued a Revised Funding Commitment Decision Letter (RFCDL) on 06/05/19 to correct the funding amount. On this RFCDL, the contract expiration date was moved back to the date that was on the original application, 7/1/18. This was a reversal of the correction made on the 4/3/19 FCDL.
- Because we believed 6/5/19 RFCDL was done merely to correct the funding amount, we did not notice the date change. It wasn’t until we were seeking reimbursement did we realize that the date had been changed.
- On 8/8/19, we contacted USAC and inquired about this. We assumed this was just a clerical error that could easily be corrected with an easy administrative remedy but were told the easiest way to do this was to file an appeal. As a Service Provider, we had never filed an appeal. USAC had to setup access for us in EPC in order for us to facilitate this. We filed the appeal immediately on 8/9/19.
- On 10/2/19, we received word that our appeal was not even considered due to it being past the 60 days of the FCDL decision on 6/5/19.

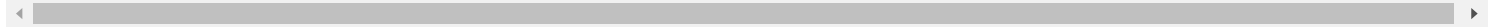

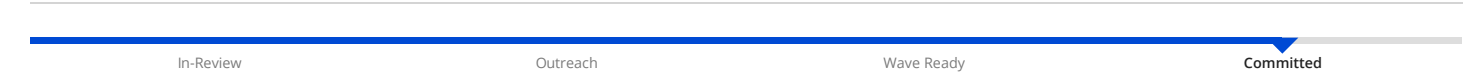
