Please don't deprive the elderly of one decent channel that they can enjoy.

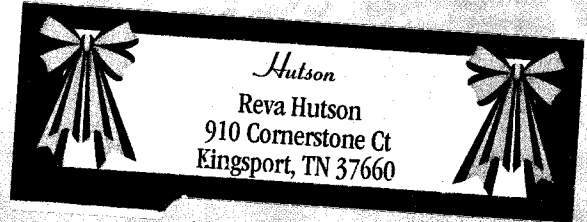

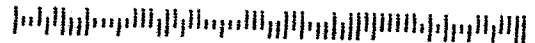


