Gentlemen;

I write to you with heavy heart and deep concerns. My recent past has been in the activities of addressing Congress and the Whitehouse; or the lack of concerns for our people by our "Do nothing Congress" and our breaking the laws of our Constitution; ignoring the making of laws by the President on his own; and ignoring the desires of the People", who are the government of this nation.

Yes, ABC, NBC, CBS gives me local news, Democrat edited news national, and international; but Democrat CNN does its international news more thorough and Fox News does the National, International and the Political coverage I believe to be of the most honest and thorough.

However for entertainment and educational of the rural life of America, bar none, it is RFD TV! I travel many states, learn about these American people in their works, hobbies, concerns, and principles, and ways of life. I get to see their lands, their homes and towns. 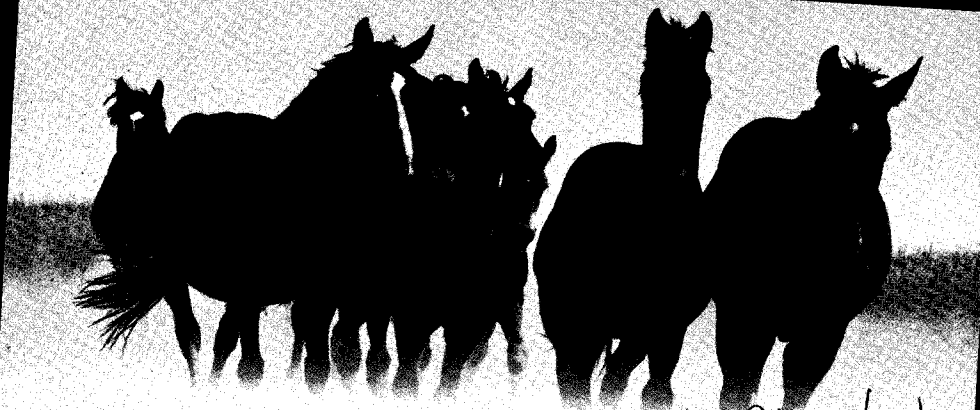
