Per Staff request, please find below answers to additional questions regarding the transaction.

1. Attached hereto are additional verifications for the Special Temporary Authority filed in this transaction.
2. We provide additional clarification on the timeline for the transactions as follows: The transfer of control of fifty-one percent (51%) of Great Wireless, LLC (parent to U.S. Connect, LLC) to Ms. Patricia Gabrysiak was consummated on March 22, 2016 (Transaction A). On December 8, 2016, a Membership Interest Assignment Agreement was initiated to assign Ms. Gabrysiak's ownership to Porter USA (Transaction B), which has not been consummated.
3. The application is being filed on a non-streamlined basis.
4. Neither of the applicants are dominant with respect to any service. None of the applicants provide overlapping service.
5. U.S. Connect, LLC is licensed as an Eligible Telecommunications Carrier in the states of W. Virginia, Maryland and Arkansas. The company provides local and long distance services in these states. Porter USA is not a telecommunications carrier.
