Dear Ms. Dortch:

On June 2, 2014, Iowa Wireless Services, LLC d/b/a iWireless ("iWireless") and its associated companies (also referred to herein as "brand partners") listed in the attachments to that letter notified the Commission of certain changes in their elections to participate in the Commercial Mobile Alert System ("CMAS"). Pursuant to Section 10.220 of the Commission's rules, iWireless now notifies the Commission that iWireless and all of its brand partners will be withdrawing from CMAS participation.

A list of the iWireless brand partners affected by this notice (i.e., that are withdrawing from CMAS participation) is attached as Exhibit A to this letter. The iWireless brand partners that continue to opt-out of CMAS participation, and whose status remains unchanged by this notice, are listed in Exhibit B. Please note that the withdrawal list may include brand partners that are no longer operating. iWireless is listing all companies that were included in the June 2, 2014 letter, with appropriate notations indicating the brand partners that are no longer providing wireless service, to ensure that the Commission's list of companies that are withdrawing from the CMAS program is accurate. iWireless and its operational brand partners will provide the required notice to customers set forth in Section 10.240(d), 47 C.F.R. § 10.240(d).
