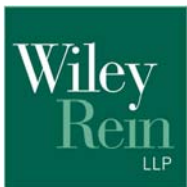
Dear Ms. Dortch:

Pursuant to Section 1.1206 of the Federal Communications Commission's ("FCC" or "Commission") rules, this letter provides notice that on November 28, 2017, Susan H. Crandall, Associate General Counsel of Intelsat Corporation ("Intelsat"), and Peter K. Pitsch, Executive Director, Federal Relations and Associate General Counsel of Intel Corporation ("Intel"), met with Erin McGrath, Legal Advisor to Commissioner O'Rielly, concerning the above-listed proceeding.

The parties discussed Intelsat's and Intel's market-based approach to simultaneously enable flexible terrestrial mobile use in the 3.7-4.2 GHz band and protect incumbent satellite operations, as proposed in joint comments by Intelsat and Intel in response to the FCC's Notice of Inquiry on flexible use of mid-band spectrum.<sup>1</sup> Intelsat and Intel suggested that the FCC move forward on a Notice of Proposed Rulemaking that would propose a sharing framework based on the Intelsat/Intel proposal. Intelsat and Intel noted that they stand ready to work with the FCC and other stakeholders concerning the details of how the proposal would be implemented.
