Subject: Re: your vote to repeal our freedom

To the FCC Commissioners and other applicable committees,

Outside of broadband companies, nobody in America wants you to repeal the laws that protect net neutrality. Nobody in America wants you to take away our freedom to communicate, to collaborate, to create, to make use of a product that we already pay for (some of us already pay exorbitant amounts of money for internet access due to monopolies in our area). The only reason you would choose to make the decision to revoke our freedom is if you were being paid by ISPs to do so. Are you not a group that is meant to serve the public?

According to Wikipedia (which I can fortunately access without having to pay extra fees to my ISP, but it may not be that way next month), the current mission of the FCC includes some of the following:

1. *"All Americans should have **affordable access** to robust and reliable broadband products and services. Regulatory policies **must promote technological neutrality**, competition, investment, and **innovation** to ensure that broadband service providers have sufficient incentives to develop and offer such products and services."*

However, by repealing neutrality laws, you are ensuring the exact opposite.

How are you planning to make it so that Americans have affordable access broadband products and services when you want to make it legal for ISPs to raise the price just to access specific websites and features?

*"Competition in the provision of communication services, both domestically and overseas, **supports the Nation's economy**. The competitive framework for communications services should foster innovation and offer consumers **reliable, meaningful choice in affordable services**."*

This is the one you should be focusing on. Many people are living in areas where one broadband provider has a monopoly, and this is happening all over, not just in rural areas! I've lived all over the country, but I currently live in Las Vegas, NV (a sizeable city). Elsewhere in the country, I've always had at least two viable ISPs to choose from and only paid about \$35-45 for internet access. I now pay \$75 for basic internet with a slower speed, because there is only one ISP to choose from here. If this is one of your supposed goals, why not focus on this rather than trying to make it so people like me will no longer be able to afford internet at all?

3. *"The Nation's media regulations must promote competition and diversity and facilitate the transition to digital modes of delivery."*

Repealing neutrality laws does the opposite of this as well. There will be no diversity in digital space when we are only permitted to consume the services which our ISP dictates! You may argue that we can switch to an ISP of our choosing, but as I said above, there are so many people who live without choice of broadband provider!

4. *"The Commission shall strive to be highly productive, adaptive, and innovative organization that **maximizes the benefits to stakeholders, staff, and management from effective systems, processes, resources, and organizational culture.**"*

Honestly, the bold part here seems to be the only one of the goals you are working toward- pleasing the multi-billionaires who have most likely paid you to take away our freedoms.

I'm sorry if I sound harsh, as it's typically unlike me to be anything but polite, but you are threatening to take away freedoms of **every** American, and we will not stand for it. Please consider what I've said, and what millions of others are saying: *we do not want this.*
