SECOND STATUS REPORT ON SETTLEMENT

Pursuant to Order, FCC 93M-346, released June 8, 1993, Steven L. Gradick ("Gradick") and Terry C. Jenks ("Jenks"), by their attorneys, jointly report on the status of their settlement.

As the Presiding Judge has been advised by the Settlement Status Report and Joint Motion for Immediate Suspension of Procedural Dates filed June 4, 1993, Gradick and Jenks have reached a settlement agreement in principle. However, as discussed previously, the two Petitions for Reconsideration of the allotment of Channel 288A to Bowdon, Georgia, in the Report and Order in MM Docket No. 90-309, DA 91-887, (Chief, Allocations Branch, released August 13, 1991) remain pending as the Mass Media Bureau ("Bureau") continues to review the separate


