farm equipment shows, And farm machinery available on today's markets. We love anything connected to farm life.

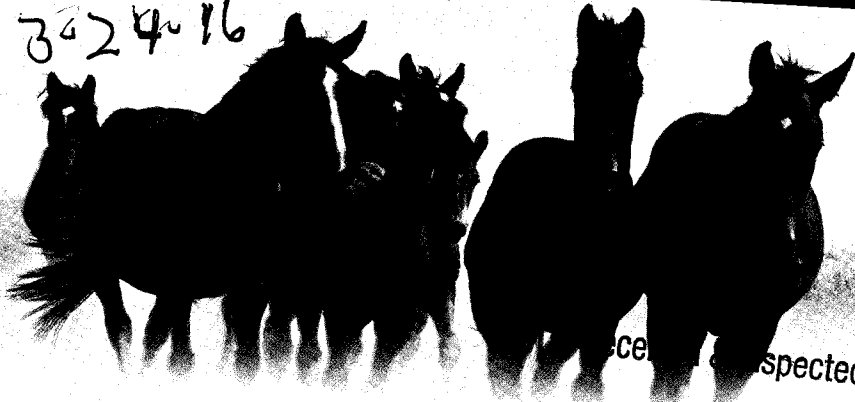
We would love for RFD-TV to run "The Antique Road Show" on their channel. This is great for all ages that appreciate collecting beautiful items that keep our history alive.
