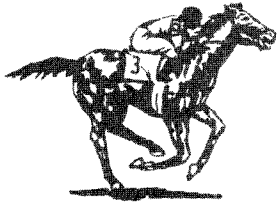



DEAR FCC,

I HAVE WATCHED RFD TV ON TIME WARNER CABLE EVER SINCE THEY BEGAN OFFERING IT. I KNOW RFD TV WAS AVAILABLE ON SATELLITE SYSTEMS WAY BEFORE TIME WARNER PICKED IT UP BECAUSE I WATCHED CERTAIN PROGRAMS ON MY FRIENDS' SATELLITE SYSTEMS.

IT TROUBLES ME THAT THE EXISTANCE OF A FINE FAMILY FRIENDLY STATION LIKE RFD IS THREATENED BY SOME OF THE LARGE URBAN BASED TELEVISION SYSTEMS THAT SEEM TO WANT TO ELIMINATE SMALL INDEPENDENT STATIONS LIKE RFD. I AM NEITHER A FARMER OR RANCHER, BUT MY FAMILY AND I ENJOY A LOT OF THE PROGRAMMING RFD TV OFFERS THAT CANNOT BE FOUND ON OTHER CHANNELS.

ALTHOUGH I HAVE NOT HEARD OF ANY RECENT PLANS BY TIME-WARNER TO DROP RFD TV IN THIS AREA, THERE WAS CONCERN A FEW MONTHS BACK WHEN THEY WERE TALKING OF MERGING WITH A LARGER COMPANY WHICH HAD DROPPED RFD TV FROM AREAS A LOT MORE RURAL THAN WHERE WE LIVE. COMPANIES SAY THAT BANDWIDTH IS GETTING MORE RESTRICTED, YET TIME WARNER DUPLICATES CHANNELS LIKE HISTORY, DISCOVERY, ANIMAL PLANET AND MANY OTHERS TWO AND THREE TIMES ON MY CABLE PACKAGE, YET THEY WON'T INCLUDE THE HIGH DEFINITION RFD TV CHANNEL EVEN ONCE! THEIR MUSIC CHANNELS HAVE FOUR OR FIVE SELECTIONS EACH OF POP, RAP, COUNTRY AND LATINO MUSIC, YET THEY REMOVED THE ONLY BLUEGRASS MUSIC CHANNEL WHICH WAS A FAVORITE OF MANY PEOPLE IN THIS AREA WITH APPALACHIAN ROOTS.

I HOPE SOMETHING CAN BE DONE TO PROTECT SMALLER INDEPENDENT STATIONS LIKE RFD TV FROM THE HATCHETS OF THE BIG URBAN MEDIA CONGLOMERATES WHO SOMETIMES DON'T SEEM TO CARE WHAT THEIR CUSTOMERS WANT. I HOPE LETTERS LIKE THIS BECOME UNNECESSARY SOON.
