PETITION FOR RULEMAKING

SSR Communications, Inc. ("Petitioner") hereby submits this Petition for Rulemaking to assign FM Channel 264A to Caliente, Nevada as that community's *first full power* FM broadcast service, as follows:

<u>Community</u>	<u>Present</u>	<u>Proposed</u>
Caliente, Nevada	---	264A

This makeup of allocations would represent a *preferential arrangement of the FM Table of Allotments*. The community of Caliente, Nevada would receive its first FM allocation. Caliente is an incorporated community (generally sufficient for allotment purposes) within Lincoln County, Nevada, with a 2010 United States Census population of 1,130 persons. Caliente has its own schools (Caliente Elementary, C.O. Bastian High School, et cetera), fire department, police department, churches, and many other indicators of a bona-fide community for allotment purposes. Caliente is independent of any neighboring communities and is clearly deserving of its own FM allocation.

Concurrent with this Petition, Petitioner has filed a FCC Form 301 Construction Permit application (and associated fee) to construct a new FM facility at Caliente, Nevada. In the event that the Commission grants Petitioner's requests herein, Petitioner asserts that it will participate in any future Commission auction to secure a broadcast license for said facility.

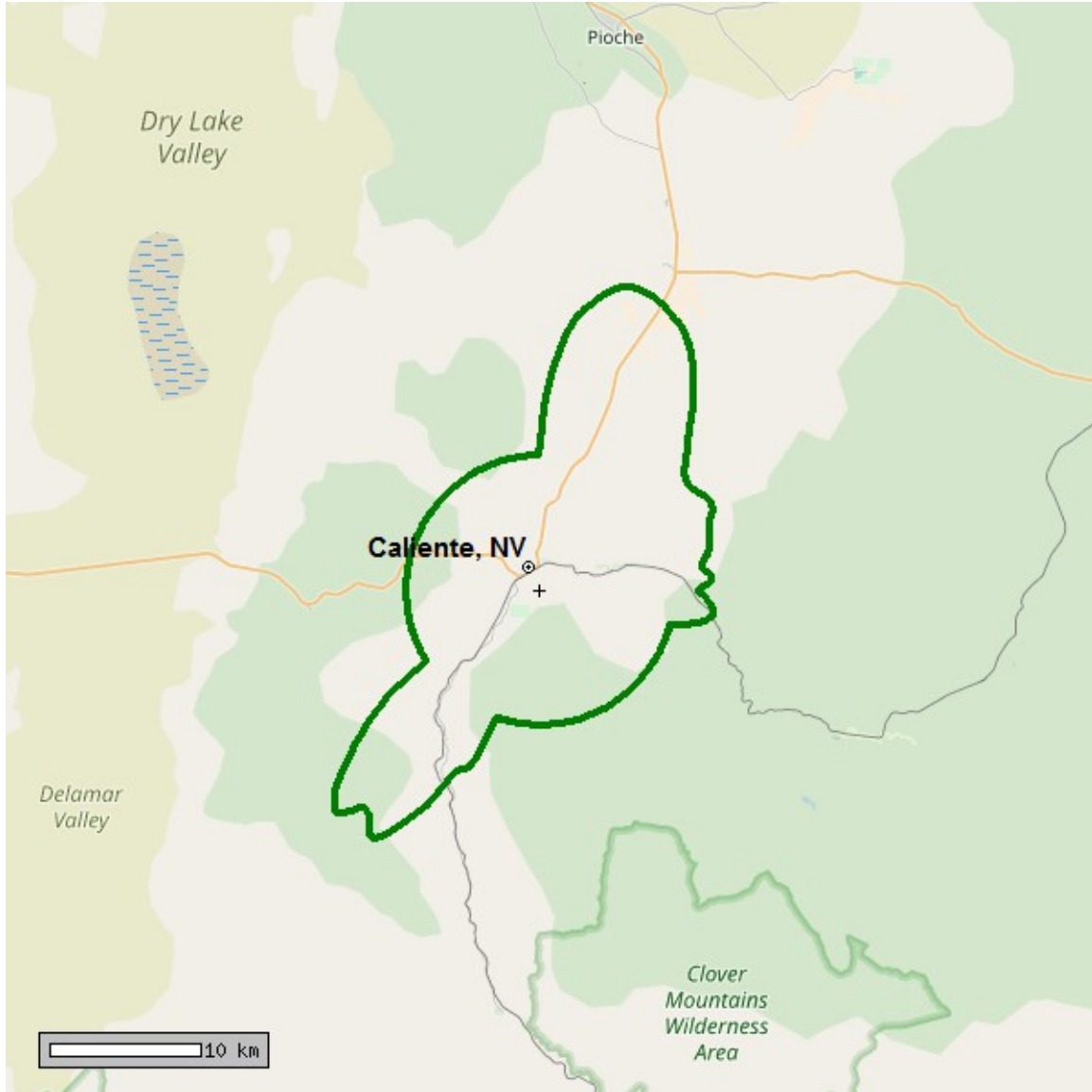
