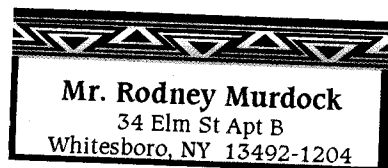

I have Dish TV, others around me have either Dish or Direct TV, because where we live there are mountains all around us. And if we just get HD TV with the boxes that were sent out, which some people requested - like my mother - we tried to get her HD boxes and they told her that they had already sent them to her but she never received them until this day. Her name was Florence P. Hensley she lived at 40 Ophard Hensley Drive, I did receive mine which I live at 26 Ophard Hensley Drive. But with the HD boxes I could only get 3 local stations - WTOS-TV in Asheville, WYFF-TV 4, and WSPA channel 7 - the last two are in D.C. and we live in WNC.

But the reason I am writing is because I have the 240 channel package - There are so many stations that are double stations, and a

lot of stations that I don't even watch but yet I still have to pay for, because they are in the "Package" I don't think that other customers &/or myself should NOT have to pay for the double channels - or the channels we never watch.

And also stop blocking the RFD-TV. Out of all the channels listed over 250 that I pay for I only watch approx 36 different channels - But yet I have to pay over \$100<sup>00</sup> a month for it - Then if it's raining, snowing, & sometimes just the wind blowing or a cloud cover I lose signal and unless I have recorded something on the DVR - I can't watch TV at all. - My Dish TV is also combined with my F&T, Telephone & internet from Frontier - all three of these together are over \$220.00 a month. Then the power bill is from \$150 - to over \$200/month, and being on Social Security disability & a fixed income it is so hard to make ends meet. I am a diabetic and I have not been able to really go get groceries because I just don't have the money, after I pay all my bills.

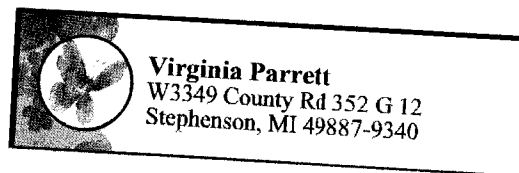
