**FCC Appeal**

**Re: Carlsbad Unified School District**

**FRN 1899017904 & 1899042290 on Application 181011104**

For FRNs 1899017904 and 1899042290, we are appealing the RFCDL that was issued for Carlsbad Unified School District on November 20, 2018. It denied our request for receiving services from 7/1/18-9/30/18, which were removed on the RFCDL from September 6, 2018. The September RFCDL denied our request for new FRN's to be created for the existing services from 7/1/18-10/1/18, which were/are still functioning **AND removed 3 months of service**, which was unequivocally incorrect. This decision was totally unjust, did not review the total situation and did not portray the E-rate program as it is meant to be.

**History**

We received our **original FCDL** on **5/26/18** and all was approved as submitted. We had applied for **new ATT Services** (ASE and ADE circuits) on our 471 181011104 for 7/1/18-6/30/19. In late July, 2018, we received an email from Ron Koning, ATT Project Manager (attached), that the new services would not install by 7/1/18 nor could they state an exact date for installation but it would be by or after 9/30/18.

We filed an appeal on 7/25/18 (#116953, attached) to request USAC to add two new FRN's for the dates of 7/1/18-9/30/18 for the current services (OPTEMAN FRN and GIGAMAN FRN) and shorten the current FRN's to 10/1/18-6.30/19. The current and future services are for the same purpose: the District's WAN (OPTEMAN, replaced by ASE) and their connection to their ISP (GIGAMAN, replaced by ADE). USAC shortened the current FRN's but did not grant us new FRN's to cover the first three months.

The description of the denial suggests that we cannot amend our 471 applications after they have been approved. I've been working with Erate since 1998 and, in the past, we have had FRN's amended, even after the FCDL.

CUSD is paying over \$10,900 a month for FRN 1899017904 for the old OPTEMAN service, yet we only requested \$6,970.80 per month for the new ASE services. CUSD

has been paying \$2200 per month for GIGAMAN and we only requested \$1263 per month for the new ADE service. Invoices attached as reference.

If USAC refuses to add the new FRN's with additional funding for the existing services, we still want the FCC to return funding for 7/1/18-10/1/18 to cover the original 471 and approved FCDL funding.

**The first three months of funding should be re-instated.** If we can't have more funding to cover actual costs, **we should still be allowed 3 months of funding at the rates requested and approved on the FCDL.** The District should not be without funding for 3 months when they clearly have followed all of the procurement rules and E-rate procedures. The District should not be penalized for the vendor failing to install services on time.

The primary objective of USAC is to ensure the schools benefit from the Erate program and denying funding is totally unacceptable.

There is no evidence of waste, fraud, abuse or misuse of funds or a failure to adhere to the core program requirements. It would be a disservice and inflict undue hardship to remove \$12,351.51 (post discount) of funding for the Carlsbad Unified School District when they are, obviously, using these services (OPTEMAN and GIGAMAN) until the new services are installed. We have demonstrated that we have complied with USAC's application procedures for these services and the District should not be penalized for the inability of a vendor to install services on time.

If the FCC can grant us new FRN's from 7/1/18-10/1/18, we would like to request \$10,919.61 per month for the new FRN, covering OPTEMAN, and \$2,196.37 per month, covering GIGAMAN. If the FCC cannot, please reinstate \$20,912.40 pre-discount for FRN 1899017904 (\$6,970.80 x 3 months) and \$3,790.62 for FRN 1899042290 (\$1,263.54 x 3 months) and change the service dates back to 7/1/18-6/30/19. The total, pre-discount, for FRN 1899017904 would be \$83,649.60 and the total for FRN 1899042290 would be \$15,162.48 for the year, which was approved on the original FCDL.
