As a state representative from Massachusetts who works closely with my local media station in Revere, Massachusetts, I write to support the Comments of the Cable Act Preservation Alliance ("CAPA") and to disapprove of the proposals and tentative conclusions set forth in the FCC's September 25 Further Notice of Proposed Rule Making in Implementation of Section 621(a)(1) of the Cable Communications Policy Act of 1984 as Amended by the Cable Television Consumer Protection and Competition Act of 1992, MB Docket 05- 311.

As a founding Board member of RevereTV in the City of Revere, Massachusetts, I want to voice my strong support for our local cable television media station. Because of the efforts of its executive director Robert Dunbar, the dedicated staff and devoted volunteers, RevereTV has grown to become a tool that many residents in our community utilize to learn about what is going on around the City.

The station has greatly helped spread the word about local news and events. Whether it is an official public meeting, the world-famous annual International Sand Sculpting Festival or the Revere Santa Walk, representatives from RevereTV are present at almost every major and minor event in our community to capture these meaningful moments so that residents can feel like they are participating in events they might otherwise not have been able to see or attend.
