**JOINT STIPULATION BETWEEN THE ENFORCEMENT BUREAU AND MARITIME  
ON DISCONTINUANCE OF OPERATIONS  
OF PREVIOUSLY STIPULATED SITE-BASED FACILITIES**

1. On June 17, 2014, the Presiding Judge issued *Memorandum Opinion and Order*, FCC 14M-18, which granted summary decision on the timely construction aspect of Issue (g), but denied summary decision on the permanent discontinuance aspect of Issue (g) for 16 site-

based facilities licensed to Maritime Communications/Land Mobile, LLC (Maritime).<sup>1</sup> This Order also rejected joint stipulations entered into between the Enforcement Bureau (Bureau) and Maritime concerning an additional 153 licenses (the Stipulated Facilities),<sup>2</sup> thereby putting at issue for trial the timely construction and operational status of these facilities.<sup>3</sup> On August 21, 2014, the Presiding Judge indicated his willingness to “consider well-crafted stipulations that obviate the need to examine factual matters”<sup>4</sup> and indicated that he would rule favorably on a stipulation if “all litigating parties unanimously agree that the record now establishes that operations at the stipulated facilities have been permanently discontinued.”<sup>5</sup>

2. In an effort to obviate the need to examine at hearing the particular factual matters concerning the operational status of the Stipulated Facilities, the Bureau and Maritime coordinated with Mr. Havens and counsel for Environmental LLC and Verde Systems LLC (collectively, ENL-VSL) in the hopes that all litigating parties could reach agreement on the facts set forth below. It is the Bureau and Maritime’s understanding that ENL-VSL and Mr. Havens agreed that all of the Stipulated Facilities should be deemed automatically terminated under Section 1.955(a) of the Commission’s rules, but that ENL-VSL and Mr. Havens otherwise refused to stipulate to any of the facts that form the basis for the instant Joint Stipulation On Discontinuance Of Operations Of Previously Stipulated Site-Based Facilities (Joint Stipulation). Nevertheless, the Bureau and Maritime hereby enter into this Joint Stipulation, in which

Maritime concedes that operations at the Stipulated Facilities have permanently discontinued, and hereby stipulate as set forth below.<sup>6</sup>

### **JOINT STIPULATION**

#### **KA98265**

3. VHF facility KA98265 is not operating or providing maritime and/or land mobile communications services to VHF subscribers.

4. On May 14, 2012, Maritime filed an application (File No. 0005210655) to cancel the authorization for this facility with the Wireless Telecommunications Bureau (Wireless Bureau).

5. The application was granted and the Commission's Universal Licensing System (ULS) shows the status of this license as CANCELED.

6. Attached as Exhibit 1, hereto, is a true and correct copy of a print-out from ULS reflecting that this license was CANCELED as of May 14, 2012.

Jul. 29, 2014) at 2-3. Nevertheless, Choctaw understands that, as a party to this proceeding, it will be bound by any *Order* from the Presiding Judge which adopts the proposed Joint Stipulation in whole or in part.

### **KCE278**

7. Site-based facility KCE278 is not operating or providing maritime and/or land mobile communications services to AMTS subscribers.

8. On May 17, 2012, Maritime filed an application (File No. 0005223604) to cancel the authorization for this facility with the Wireless Bureau.

9. The application was granted and the Commission's ULS shows the status of this license as CANCELED.

10. Attached as Exhibit 2, hereto, is a true and correct copy of a print-out from ULS reflecting that this license was CANCELED as of May 22, 2012.

### **KPB531**

11. Site-based facility KPB531 is not operating or providing maritime and/or land mobile communications services to AMTS subscribers.

12. On May 17, 2012, Maritime filed an application (File No. 0005223606) to cancel the authorization for this facility with the Wireless Bureau.

13. The application was granted and the Commission's ULS shows the status of this license as CANCELED.

14. Attached as Exhibit 3, hereto, is a true and correct copy of a print-out from ULS reflecting that this license was CANCELED as of May 22, 2012.

### **KUF732**

15. Site-based facility KUF732 is not operating or providing maritime and/or land mobile communications services to AMTS subscribers.

16. On May 17, 2012, Maritime filed an application (File No. 0005223607) to cancel the authorization for this facility with the Wireless Bureau.

17. The application was granted and the Commission's ULS shows the status of this license as CANCELED.

18. Attached as Exhibit 4, hereto, is a true and correct copy of a print-out from ULS reflecting that this license was CANCELED as of May 22, 2012.

#### **WFN**

19. HF/VHF facility WFN is not operating or providing maritime and/or land mobile communications services to HF or VHF subscribers.

20. On May 14, 2012, Maritime filed an application (File No. 0005210663) to cancel the authorization for this facility with the Wireless Bureau.

21. The application was granted and the Commission's ULS shows the status of this license as CANCELED.

22. Attached as Exhibit 5, hereto, is a true and correct copy of a print-out from ULS reflecting that this license was CANCELED as of May 17, 2012.

#### **WHW848**

23. Temporary-Fixed facility WHW848 is not operating or providing maritime and/or land mobile communications services to AMTS subscribers.

24. On May 15, 2012, Maritime filed an application (File No. 0005214809) to cancel the authorization for this facility with the Wireless Bureau.

25. The application was granted and the Commission's ULS shows the status of this license as CANCELED.

26. Attached as Exhibit 6, hereto, is a true and correct copy of a print-out from ULS reflecting that this license was CANCELED as of May 15, 2012.

### **WHX877**

27. Station WHX877, which was authorized to operate in the 9 GHz band solely for the purpose of testing marine radiotermination equipment, is not operating.

28. On May 14, 2012, Maritime filed an application (File No. 0005210664) to cancel the authorization for this facility with the Wireless Bureau.

29. The application was granted and the Commission's ULS shows the status of this license as CANCELED.

30. Attached as Exhibit 7, hereto, is a true and correct copy of a print-out from ULS reflecting that this license was CANCELED as of May 14, 2012.

### **WRD580**

31. VHF facility WRD580 is not operating or providing maritime and/or land mobile communications services to VHF subscribers.

32. On May 14, 2012, Maritime filed an application to cancel the authorization for this facility with the Wireless Bureau.

33. The Commission's ULS shows the status of this license as CANCELED.

34. Attached as Exhibit 8, hereto, is a true and correct copy of a print-out from ULS reflecting that this license was CANCELED as of May 17, 2012.

### **WHG693, WHG701-703, WHG705--WHG754 (Block A and Block B)**

35. Neither frequency Block A nor frequency Block B of call signs WHG693, WHG701-703, WHG705-WHG749, and WHG751-WHG754 are currently being used to provide maritime and/or land mobile communications services to AMTS subscribers.

36. Frequency Block A of call sign WHG750 is not currently being used to provide maritime and/or land mobile communications services to AMTS subscribers.

37. Site-based facilities WHG693, WHG707, and WHG754 had become nonoperational by the time Maritime acquired these facilities in December 2005.

38. Maritime ceased providing service to end user customers via frequency Block A and frequency Block B of call signs WHG701-703, WHG705-WHG706, WHG708-WHG749, and WHG751-WHG753 as of December 31, 2007.

39. Maritime ceased providing service to end user customers via frequency Block A of call sign WHG750 as of December 31, 2007.

40. Maritime has made no effort to maintain frequency Block A of site-based facilities WHG693, WHG701-703, and WHG705-WHG754 in operational status since deciding to voluntarily cancel the authorizations for these facilities shortly before May 31, 2012.

41. Maritime has made no effort to maintain frequency Block B of site-based facilities WHG693, WHG701-703, WHG705-WHG749, and WHG751-WHG754 in operational status since deciding to voluntarily cancel the authorizations for these facilities shortly before December 2, 2013.

42. Maritime has no plans to resume operations of frequency Block A of site-based facility WHG750.

43. Maritime has no plans to resume operations of either frequency Block A or frequency Block B of site-based facilities WHG693, WHG701-703, WHG705-WHG749, and WHG751-WHG754.

44. Choctaw has no plans to resume operations of frequency Block A of site-based facility WHG750.



45. Choctaw has no plans to resume operations of either frequency Block A or frequency Block B of site-based facilities WHG693, WHG701-703, WHG705-WHG749, and WHG751-WHG754.

46. Operations of frequency Block A of site-based facility WHG750 have been permanently discontinued.

47. Operations of frequency Block A and frequency Block B at site-based facilities WHG693, WHG701-703, WHG705-WHG749, and WHG751-WHG754 have been permanently discontinued.

48. For the purposes of this proceeding, operations of frequency Block A of site-based facilities WHG693, WHG701-703, and WHG705-WHG754 permanently discontinued as of May 31, 2012.

49. For the purposes of this proceeding, operations of frequency Block B of site-based facilities WHG693, WHG701-703, WHG707-WHG749, and WHG751-WHG754 permanently discontinued as of December 2, 2013.

50. Pursuant to Section 1.955(a)(3) of the Commission's rules, 47 C.F.R. § 1.955(a)(3), site-based authorizations WHG693, WHG701-703, WHG705-WHG749, and WHG751-WHG754 automatically terminated as of the dates of permanent discontinuance.

51. Pursuant to Section 1.955(a)(3) of the Commission's rules, 47 C.F.R. § 1.955(a)(3), frequency Block A of site-based authorization WHG750 automatically terminated as of the date of permanent discontinuance.

52. Maritime has already filed applications with the Wireless Bureau to delete frequency Block A from site-based authorizations WHG693, WHG701-703, WHG705-WHG725, and WHG727-WHG754, as set forth in the following table. Each of these applications remains pending.

53. Maritime agrees to file a Form 601 request to cancel site-based authorizations WHG693, WHG701-703, WHG705-WHG749, and WHG751-WHG754 in their entirety prior to

the commencement of the hearing in this matter, provided the Presiding Judge issues an *Order* adopting the instant Joint Stipulation and authorizing Maritime to cancel these authorizations.

54. If the Commission grants the application to assign the authorizations for the Stipulated Facilities to Choctaw before the Presiding Judge issues an *Order* adopting the instant Joint Stipulation, Choctaw agrees to file a Form 601 request to cancel site-based authorizations WHG693, WHG701-703, WHG705-WHG749, and WHG751-WHG754 in their entirety prior to the commencement of the hearing in this matter, provided the Presiding Judge issues an *Order* adopting the instant Joint Stipulation and authorizing cancellation of these authorizations.

**KAE889 – Locations 6, 8, 12, 14, 22, 26-28, 33, 37, 39, 40, 44, 46**

55. Site-based facilities KAE889 – Locations 6, 8, 12, 14, 22, 26-28, 33, 37, 39, 40, 44, and 46 are not currently being used to provide maritime and/or land mobile communications services to AMTS subscribers.

56. KAE889 – Locations 6, 8, 12, 22, 26-28, 33, 37, 39, 40, 44, and 46 were operated in MPT1327 format as part of the “West Coast” regional system providing maritime and/or land mobile communications services to AMTS subscribers. This system ceased providing service as of December 31, 2007.

57. KAE889 – Location 14 was operated in MPT1327 format as part of the “West Coast” regional system until December of 2007, and thereafter continued operating and providing service until the station was deactivated in 2010 to avoid interferences with operations of the Southern California Regional Rail Authority

58. Maritime has made no effort to maintain site-based facilities KAE889 – Locations 8, 14, 26-28, 33, 37, 39, 40, and 44 since deciding to voluntarily cancel the authorizations for these facilities shortly before May 31, 2012.

59. Maritime has made no effort to maintain site-based facilities KAE889 – Locations 6, 12, 22, and 46 since deciding to voluntarily cancel the authorizations for these facilities shortly before December 2, 2013.

60. Maritime has no plans to resume operations at site-based facilities KAE889 – Locations 6, 8, 12, 14, 22, 26-28, 33, 37, 39, 40, 44, and 46.

61. Choctaw has no plans to resume operations at site-based facilities KAE889 – Locations 6, 8, 12, 14, 22, 26-28, 33, 37, 39, 40, 44 and 46.

62. Operations at site-based facilities KAE889 – Locations 6, 8, 12, 14, 22, 26-28, 33, 37, 39, 40, 44, and 46 have been permanently discontinued.

63. For the purposes of this proceeding, operations at KAE889 – Locations 8, 14, 26-28, 33, 37, 39, 40, and 44 permanently discontinued as of May 31, 2012.

64. For the purposes of this proceeding, operations at KAE889 – 6, 12, 22 and 46 permanently discontinued as of December 2, 2013.

65. Pursuant to Section 1.955(a)(3) of the Commission's rules, 47 C.F.R. § 1.955(a)(3), site-based authorizations KAE889 – Locations 6, 8, 12, 14, 22, 26-28, 33, 37, 39, 40, 44, and 46 automatically terminated as of the dates of permanent discontinuance.

66. On May 30, 2012, Maritime filed an application (File No. 0005223613) to modify site-based authorization KAE889 to delete Locations 8, 14, 26-28, 33, 37, 39, 40, and 44 from this authorization. The Wireless Bureau has not yet granted this application.

67. Maritime agrees to file an additional application to modify site-based authorization KAE889 to delete Locations 6, 12, 22, and 46 from this authorization prior to the commencement of the hearing in this matter, provided the Presiding Judge issues an *Order* adopting the instant Joint Stipulation and authorizing Maritime to make such deletions.

68. If the Commission grants the application to assign the authorizations for the Stipulated Facilities to Choctaw before the Presiding Judge issues an *Order* adopting the instant Joint Stipulation, Choctaw agrees to file an application to modify site-based authorization KAE889 to delete Locations 6, 12, 22, and 46 from this authorization prior to the commencement of the hearing in this matter, provided the Presiding Judge issues an *Order* adopting the instant Joint Stipulation and authorizing such deletions.

**WRV374 – Locations 2, 3, 8, 12, 17, 19, 20, 22-24, 26-29, 31, 34, 36, 39**

69. Site-based facilities WRV374 – Locations 2, 3, 8, 12, 17, 19, 20, 22-24, 26-29, 31, 34, 36, and 39 are not currently being used to provide maritime and/or land mobile communications services to AMTS subscribers.

70. Maritime ceased providing to end user customers via site-based facilities WRV374 – Locations 2, 3, 8, 12, 17, 19, 20, 22-24, 26-29, 31, 34, 36, and 39 in 2007.

71. Maritime has made no effort to maintain site-based facilities WRV374 Locations 2, 3, 17, 24, 27-29, 31, and 36 since deciding to voluntarily cancel the authorizations for these facilities shortly before May 31, 2012.

72. Maritime has made no effort to maintain site-based facilities WRV374 Locations 8, 12, 19, 20, 22, 23, 26, 34, and 39 since deciding to voluntarily cancel the authorizations for these facilities shortly before December 2, 2013.

73. Maritime has no plans to resume operations at site-based facilities WRV374 – Locations 2, 3, 8, 12, 17, 19, 20, 22-24, 26-29, 31, 34, 36, and 39.

74. Choctaw has no plans to resume operations at site-based facilities WRV374 – Locations 2, 3, 8, 12, 17, 19, 20, 22-24, 26-29, 31, 34, 36, and 39.

75. Operations at site-based facilities WRV374 – Locations 2, 3, 8, 12, 17, 19, 20, 22-24, 26-29, 31, 34, 36, and 39 have been permanently discontinued.

76. For the purposes of this proceeding, operations at site-based facilities WRV374 – Locations 2, 3, 17, 24, 27-29, 31, and 36 permanently discontinued as of May 31, 2012.

77. For the purposes of this proceeding, operations at site-based facilities WRV374 – Locations 8, 12, 19, 22, 23, 26, 34, and 39 permanently discontinued as of December 2, 2013.

78. Pursuant to Section 1.955(a)(3) of the Commission's rules, 47 C.F.R. § 1.955(a)(3), site-based authorizations WRV374 – Locations 2, 3, 8, 12, 17, 19, 20, 22-24, 26-29, 31, 34, 36, and 39 automatically terminated as of the dates of permanent discontinuance.

79. Maritime agrees to file an application to modify site-based authorization WRV374 to delete Locations 2, 3, 8, 12, 17, 19, 20, 22-24, 26-29, 31, 34, 36, and 39 from this authorization prior to the commencement of the hearing in this matter, provided the Presiding Judge issues an *Order* adopting the instant Joint Stipulation and authorizing Maritime to make such deletions.

80. If the Commission grants the application to assign the authorizations for the Stipulated Facilities to Choctaw before the Presiding Judge issues an *Order* adopting the instant Joint Stipulation, Choctaw agrees to file an application to modify site-based authorization WRV374 to delete Locations 2, 3, 8, 12, 17, 19, 20, 22-24, 26-29, 31, 34, 36, and 39 prior to the commencement of the hearing in this matter, provided the Presiding Judge issues an *Order* adopting the instant Joint Stipulation and authorizing such deletions.

### **WHV733 – Locations 1, 2, 3**

81. Site-based facilities WHV733 – Locations 1, 2, and 3 are not currently being used to provide maritime and/or land mobile communications services to AMTS subscribers.

82. Maritime ceased providing to end user customers via site-based facilities WHV733 – Locations 1, 2, and 3 as of December 31, 2007.

83. Maritime has made no effort to maintain site-based facilities WHV733 – Locations 1, 2, and 3 since deciding to voluntarily cancel the authorizations for these facilities shortly before December 2, 2013.

84. Maritime has no plans to resume operations at site-based facilities WHV733 – Locations 1, 2, and 3.

85. Choctaw has no plans to resume operations at site-based facilities WHV733 – Locations 1, 2, and 3.

86. Operations at site-based facilities WHV733 – Locations 1, 2, and 3 have been permanently discontinued.

87. For the purposes of this proceeding, operations at site-based facilities WHV733 – Locations 1, 2, and 3 permanently discontinued as of December 2, 2013.

88. Pursuant to Section 1.955(a)(3) of the Commission's rules, 47 C.F.R. § 1.955(a)(3), site-based authorization WHV733 – Locations 1, 2, and 3 automatically terminated at the date of permanent discontinuance.

89. Maritime agrees to file a Form 601 request to cancel site-based authorization WHV733 – Locations 1, 2, and 3 prior to commencement of the hearing in this matter, provided the Presiding Judge issues an *Order* adopting the instant Joint Stipulation and authorizing Maritime to cancel this authorization.

90. If the Commission grants the application to assign the authorizations for the Stipulated Facilities to Choctaw before the Presiding Judge issues an *Order* adopting the instant Joint Stipulation, Choctaw agrees to file an application to cancel site-based authorization

92. Maritime ceased providing to end user customers via site-based facility WHV740 – Location 2 as of December 31, 2007.

93. Maritime has made no effort to maintain site-based facility WHV740 – Location 2 since deciding to voluntarily cancel the authorizations for these facilities shortly before December 2, 2013.

94. Maritime has no plans to resume operations at site-based facility WHV740 – Location 2.

96. Operations at site-based facility WHV740 – Location 2 have been permanently discontinued.

97. For the purposes of this proceeding, operations at site-based facility WHV740 – Location 2 permanently discontinued as of December 2, 2013.

98. Pursuant to Section 1.955(a)(3) of the Commission's rules, 47 C.F.R. § 1.955(a)(3), site-based authorization WHV740 – Location 2 automatically terminated at the date of permanent discontinuance.



99. Maritime agrees to file a Form 601 request to cancel site-based authorization WHV740 - Location 2 prior to commencement of the hearing in this matter, provided the Presiding Judge issues an *Order* adopting the instant Joint Stipulation and authorizing Maritime to cancel this authorization.

100. If the Commission grants the application to assign the authorizations for the Stipulated Facilities to Choctaw before the Presiding Judge issues an *Order* adopting the instant Joint Stipulation, Choctaw agrees to file an application to cancel site-based authorization WHV740 - Location 2 prior to the commencement of the hearing in this matter, provided the Presiding Judge issues an *Order* adopting the instant Joint Stipulation and authorizing cancellation of this authorization.

#### **WHV843 – Locations 1, 5 and 6**

101. Site-based facilities WHV843 – Locations 1, 5 and 6 are not currently being used to provide maritime and/or land mobile communications services to AMTS subscribers.

102. Maritime ceased providing to end user customers via site-based facilities WHV843 – Locations 1 and 5 as of December 31, 2007.

103. Maritime has made no effort to maintain site-based facility WHV843 – Locations 1, 5 and 6 since deciding to voluntarily cancel the authorizations for these facilities shortly before December 2, 2013.

104. Maritime has no plans to resume operations at site-based facilities WHV843 – Locations 1, 5 and 6.

105. Choctaw has no plans to resume operations at site-based facilities WHV843 – Locations 1, 5 and 6.

106. Operations at site-based facilities WHV843 – Locations 1, 5 and 6 have been permanently discontinued.

107. For the purposes of this proceeding, operations at site-based facilities WHV843 – Locations 1, 5 and 6 permanently discontinued as of December 2, 2013.

108. Pursuant to Section 1.955(a)(3) of the Commission's rules, 47 C.F.R. § 1.955(a)(3), site-based authorization WHV843 – Locations 1, 5 and 6 automatically terminated at the date of permanent discontinuance.


109. 
