**PROGRESS REPORT ON SALE OF KQOL**

Pursuant to the Presiding Judge's Order, FCC 93M-382 (released June 21, 1993), Street Stryder, by counsel, hereby reports on his progress in selling Station KQOL pursuant to the Commission's distress sale procedures.

Since the June 17, 1993 prehearing conference, four separate prospective buyers for Station KQOL have contacted Mr. Stryder or his counsel. Each has been advised to obtain an appraisal of the station and prepare to put into escrow 75% of the appraised value of the station. One such prospective buyer has presented an appraisal and has advised counsel that the purchase money will be placed in escrow within 30 days. Since Mr. Stryder has no assurance that this prospective buyer


will follow through, offers from others will continue to be entertained.
