KB Broadcasting, Inc. ("KB"), by its attorneys, hereby tenders an amendment to its application for a new FM facility on Channel 265A at Blooming Prairie, Minnesota. KB inadvertently failed to respond to Section I, Question 4. This amendment corrects that omission, as well as typographical errors in Exhibits B and D to the Form 301 application.

In Section I, Question 3, KB indicated that the instant application is for a new station in response to FCC Window Notice No. FM RM-11, released May 5, 1992. Hence, the application on its face clearly indicates that it is in response to the FCC filing window for Blooming Prairie, Minnesota and is not mutually exclusive with a renewal application. Nevertheless, for the sake of completeness, KB amends its application to check the "No" box in response to Section I, Question 4.


