STANDARD COMPARATIVE ISSUE

Ownership Structure

Ohio Radio Associates, Inc. is an Ohio corporation which was incorporated on January 31, 1992. The corporation has four (4) Directors and stockholders who each have a twenty-five (25%) per cent equity and voting interest. The Directors and stockholders are Joseph D. Carney, John J. Carney, James A. Carney (who are brothers) and John M. Mino. There are no non-voting stockholders. John J. Carney is the President. Joseph D. Carney is the Secretary and Vice President. James A. Carney is the Treasurer and Vice President. John M. Mino is the Assistant Secretary, Assistant Treasurer, and Vice President.

Integration

ORA does not propose to integrate its owners into management and thus does not claim any comparative credit for integration. However, ORA hereby notifies the Commission and the opposing parties that it intends to challenge as a matter of law the validity of the Commission's integration policy.

Diversification

Neither ORA nor its stockholders control or own (including non-voting stock or limited partnership interests) or have any cognizable or attributable interest (management, employment, consultant, trustee, officer, director, etc.) with any AM, FM, TV, or LPTV broadcast stations, cable television systems, newspapers, or other recognized medium of mass communications, other than minor stock interests of less than five (5%) per cent in publicly traded companies which might own mass media interests. ORA and its stockholders have no such non-cognizable or non-attributable interests in the Westerville or Columbus, Ohio, market area.

Auxiliary Power

ORA will provide auxiliary power at its studio and tower site.


