In accordance with Section 1.106(f) of the Commission's rules, 47 C.F.R. §1.106(f), the undersigned counsel, on behalf of the 30 individual Catholic schools of the Archdiocese of New York hereby requests leave to file the attached Supplement to the pending Consolidated Petition For Reconsideration¹

The Petition reported that among the original applicants and beneficiaries of the E-Rate Program funding sought to be recovered a number of the schools had closed. The Petition respectfully submitted that "it would be unfair and unequitable to now seek to impose on, for example, the inner-city Catholic parishes with which the closed schools were formerly affiliated, the obligation to repay these long-ago expenditures."²

In connection with further review of options for potentially seeking to compromise the COMADs under the Commission's debt collection rules, more detailed historical information about the status of each of the Schools, and the Catholic parishes with which they were/are affiliated, has been developed.

The Supplement does not seek to raise new issues. It does not include any new legal argument or authority. Its purpose is solely to further clarify the factual status of the beneficiary entities and related parishes as of this time in order to ensure a complete factual record.


The Commission has the discretion to grant leave where the "equities so require and no party would be prejudiced hereby."³ The moving parties respectfully submit that is the case in this instance. Acceptance of these additional facts into the record will "facilitate the resolution of the [Petition] based upon a full and complete factual record."⁴ Therefore, it is in the public interest to grant this motion for leave.

SUPPLEMENT TO CONSOLIDATED PETITION FOR RECONSIDERATION

This is a supplement to the Consolidated Petition For Reconsideration ("Petition") filed on behalf of 30 individual Catholic schools of the Archdiocese of New York¹.

The Petition reported that among the original applicants and beneficiaries of the E-Rate Program funding sought to be recovered a number of the schools had closed. The Petition respectfully submitted that "it would be unfair and unequitable to now seek to impose on, for example, the inner-city Catholic parishes with which the closed schools were formerly affiliated, the obligation to repay these long-ago expenditures."²

In connection with further review of options for potentially seeking to compromise the COMADs under the Commission's debt collection rules, more detailed historical information about the status of each of the Schools, and the Catholic parishes with which they were/are affiliated, has

been developed. The purpose of this supplement is solely to further clarify the status of those entities as of this time. In doing so, we provide a further annotated and revised Exhibit 1, reflecting this information.

I. THE STATUS OF THE SCHOOLS AND PARISHES WITH WHICH THEY WERE AFFILIATED

A. The Original Parish Affiliated Applicant/Beneficiary Schools

Only two (2) of the original parish-affiliated schools remain open and affiliated with the parish corporations which were in place at the time the E-Rate support subject to COMAD was received. These schools are: (1) Our Lady of Pompeii and (2) St. Joseph-Yorkville.

One (1) original parish-affiliated school remains open, but the original parish corporation that it was affiliated with was dissolved and combined with another parish, with the collective assets and liabilities of the combined parishes. This school is: (1) St. Anselm.

Eighteen (18) of the original parish-affiliated schools have been closed as parish schools, reopened, in the same locations and buildings, with the same names, under the supervision and oversight of separate, Archdiocesan-chartered regional legal entities, such as the Catholic School Region Of Manhattan, and continue to operate.³ These schools are: (1) Blessed Sacrament School (2013), (2) Immaculate Conception (2013), (3) Immaculate Conception G School (2013), (4) Incarnation Elementary School (2013), (5) Mt. Carmel/Holy Rosary (2013), (6) Our Lady Queen of Angels (2006), (7) Santa Maria (2013), (8) St. Ann-Manhattan (2013), (9) St. Brigid (2006), (10) St. Charles Borromeo (2013), (11) St. Elizabeth School (2013), (12) St. Francis of Assisi (2006), (13) St. John's Elementary, (14) St. Joseph School - Bronx (2013), (15) St. Luke, (16) St. Mark the Evangelist (2013), (17) St. Paul (2013) and (18) Our Lady of Grace (2013).

These regional entities did not assume any of the assets or liabilities of the closed parish schools. The date of closure of the original parish school is, where available, in parentheses.

Two (2) original parish-affiliated schools closed as a parish school, reopened as regional schools and then closed as a regional school as well. Those schools were: (1) St. Dominic and (2) St. Mary School.⁴

Six (6) original parish-affiliated schools closed and have remained permanently closed. These schools are: (1) Resurrection School (2006), (2) St. Aloysius (2016), (3) St. Ann-Bronx (2017), (4) St. Joseph of the Holy Family (2013), (5) St. Joseph Monroe (2013) and (6) St. Michael Academy (2010).

One (1) original school, which was not affiliated with any parish, but was run by the nuns of the Apostles of the Sacred Heart of Jesus, also closed and remained closed (2008). That is Sacred Heart Private School.

The foregoing covers all of the 30 original applicant/beneficiary schools on Revised Exhibit 1. Most of the parish school closures were due to financial reasons or declining enrollment.

B. The Parishes Affiliated With The Original Applicant/Beneficiary Schools

Separate and apart from the closure of the parish schools was the closure and combination of many of the parish corporations with which the original applicant schools were affiliated.

Fourteen (14) of the original affiliated parishes remain open. These are the parishes affiliated with the following schools: (1) Blessed Sacrament School, (2) Immaculate Conception School, (3) Immaculate Conception G School, (4) Incarnation Elementary School, (5) Our Lady of Pompeii, (6) Santa Maria, (7) St. Aloysius, (8) St. Elizabeth School, (9) St. Joseph of the Holy Family, (10) St. Joseph – Yorkville, (11) St. Luke, (12) St. Mark the Evangelist, (13) St. Michael Academy and (14) St. Brigid.

Thirteen (13) of the original affiliated parishes were closed, the parish corporations dissolved, and combined into newly constituted parish entities, with the collective assets and liabilities of the combined parishes. This process applied to the parishes originally affiliated with the following schools:⁵ (1) Mt. Carmel/Holy Rosary (2016), (2) St. Ann – Manhattan (2016), (3) St. Ann – Bronx (2016), (4) St. Anselm, (5) St. Charles Borromeo (2016), (6) St. Francis of Assisi (2016), (7) St. John’s Elementary (2016), (8) St. Joseph School – Bronx (2016), (9) St. Joseph – Monroe (2016), (10) St. Mary School (2016), (11) St. Paul School (2016), (12) Our Lady of Grace (2016), and (13) Resurrection School (2016).

Two (2) of the original affiliated parishes were closed, but the former parish corporations have not been dissolved and are overseen by the Archdiocese. These parishes are those originally affiliated with the following schools: (1) St. Dominic (2007)⁶ and (2) Our Lady Queen of Angels (2016).

Again, there was one (1) non-parish affiliated school. This was Sacred Heart Private School.

The foregoing covers all parishes affiliated with the 30 original applicant/beneficiary schools on Revised Exhibit 1.



While the two parishes did not combine as a legal matter under New York state corporate law, they are merged did so for purposes of Catholic Church Law. Our Lady Queen of Angels parish closed, although for various reasons the parish corporation has not been not dissolved.

II. CONCLUSION AND REQUEST FOR RELIEF

For the reasons set forth in the Petition, as supplemented herein, the Schools and the Archdiocese of New York respectfully submit that the Commission should reconsider its action in the Notice and rescind the COMADs that relate to the 30 individual Schools listed in Revised Exhibit 1.
