2. The PD is to spend one hour per week listening to the station and comparing spots aired to spots logged. An advertising spot is to be selected from that hour and reconciled with the related invoice. Then, a second spot from that same invoice is to be reconciled to the relevant log. In summary, the weekly audit requirement is to match one hour of actual listening to the log and check two spots for agreement with the relevant logs.

Selection Process - There are four separate dayparts between the hours of 6:00 am and 10:00 pm (6a-10a, 10a-2p, 2p-6p and 6p-10p). Select one hour from each of the dayparts, choosing a separate daypart each week in order to cover all four dayparts per month. If there are five weeks in a month, the 5th week is omitted. Once the hour to be listened to has been chosen, select the 2nd spot following the top of the hour for tracing to the invoice. From that invoice, select a spot immediately preceding or following the other spot and trace back to the log for agreement. The comparison of spots with the log include agreement of time (within five minutes) and copy. (See attached sheet)


