**REQUEST FOR APPROVAL OF

Tony Knipp ("Knipp"), proponent of the counterproposal for the allotment of FM Channel 297C2 to Gerald, Missouri (RM No. 8145), dated November 11, 1992, in the above-captioned proceeding, hereby withdraws his counterproposal to allot Channel 297C3 to Gerald, Missouri, and asks that it be dismissed. Knipp has decided not to pursue the allotment of Channel 297C3 at Gerald, Missouri, and has decided to withdraw the counterproposal from further consideration. 
DECLARATION


