AN UNDERSTANDING FOR AIRTIME COST SHARING

Dear Al:

Just a short note to confirm in writing that Media Services Agency will act as airtime agent in the sale of program and/or spot time for KMLM Television, Channel 42/Odessa, Texas.

It is our understanding that Media Services Agency will retain 15% of all cash receipts as commission for all airtime sold on behalf of KMLM. Media Services Agency will be forwarding airtime contracts for each program that is aired on KMLM. Each contract will be separate from another and will reflect the percentage amount of the network charge that is allocated to KMLM.

Media Services Agency will negotiate airtime contracts on behalf of KMLM, will act as receiver for all cash receipts and collector for all past due amounts. If an account is uncollectable, KMLM will hold Media Services Agency harmless against all liability resulting from uncollectable accounts.

Media Services Agency or KMLM has the right to cancel any sales contract with the other party with twenty-eight days written notice.

This agreement to represent KMLM will expire 10 years from date first written.
