My name is Cris Enriquez and I live at 8 Harborage Isle, Fort Lauderdale, Florida. I have been watching WHFT-TV, Channel 45, on a regular basis since six years ago. ## DECLARATION

I, Michael S. Everett, under penalty of perjury of the laws of the State of Florida and the United States of America, hereby swear that the following declaration is true and correct.

1. On July 15, 1993 I spoke to an associate of Pastor Oscar Arguero who had called to invite me and Dr. Paul Crouch to attend a meeting of a group of Hispanic pastors serving churches in the Miami area scheduled for Monday, July 19. After he had extended the invitation, and was told it was accepted, I asked if he would help channel 45 out by passing out a "Written Testimonial Form" to members of his church, and make the same request of other pastors in his organization. I told him that these forms were basically testimonies for people for whom channel 45 had had a real impact in their lives. He agreed to circulate the form if we would send a copy over to him. I sent the pastor a copy by telecopier on the same day.

2. Dr. Crouch, Danny York, a travelling companion of Dr. Crouch's, and I attended the meeting on July 19. We arrived slightly late, and there were already boxes full of Written Testimonial Forms in both English and Spanish. More were passed up or dropped in the boxes as the meeting proceeded. We subsequently received approximately 25 additional "Written Testimonial Forms" by mail.

3. At the meeting we were approached by a young man who identified himself as Andres Garcia. Mr. Garcia told Dr. Crouch

that he had once been a drug addict, but had seen a program on channel 45 which showed him the futility of his drug dependence and turned his life around. Mr. Garcia showed Dr. Crouch and I a picture of himself when he was still involved with drugs, dated November 28, 1991. The young man in front of us did not look like the same person in the picture. Dr. Crouch suggested that we get an "after" picture that night, and Mr. York took a picture of Mr. Garcia with Dr. Crouch. I have attached a copy of Mr. Garcia's picture and that taken with Dr. Crouch to this Declaration.


