Regrettably, however, the same mistakes made in the Odessa assignment application were also in the Portland application when it was prepared in my office. Here again, none of these errors were intentional, and the information was correctly shown in other filings.

33. At no time did I advise NMTV, TBN, or Mrs. Duff and Dr. Crouch, that the relationship between NMTV and TBN, which included the characteristics I have listed in paragraph 24 above, violated any Commission rule or policy. To the contrary, I believed that the Commission was encouraging group owners to work with minority owned companies and have a cognizable interest, so as to foster a close working relationship that would enable the minority owned company to succeed. This was and is my understanding of the Commission's policy. As an attorney, I can do no more than advise my clients in good faith and to the best of my ability, and that is what I did in this case.




Enclosed please find the first billing under the retainer arrangement Paul and I agreed upon. As a review, it was agreed that the Trinity organization would pay a monthly retainer of [REDACTED] which would cover [REDACTED] (20) hours of lawyer time a month based on a [REDACTED] an hour charge. Any hours billed in excess of that limit would be separately itemized and billed at [REDACTED] an hour. Disbursements are, of course, separately itemized and not covered under the retainer agreement. The enclosed statement itemizes this retainer and billing understanding.

Unlike the arrangement with Gammon & Grange, since the retainer covers the Trinity and Trinity-related work I have not prepared statements for the individual entities as was done in the past, although an hourly breakdown is provided. I bring this to your attention since at least TBA has been separately billed in the past, but unless you advise otherwise will be billed in the manner in which the enclosed statement has been prepared.

Finally, should you ever desire a narrative itemization of the work done you have but only to ask; however, it will not be provided as a matter of course. This will enable me to keep my administrative costs and hourly rates to a minimum.



This will confirm our conversations regarding this office's retainer agreement with Trinity, its affiliated companies, and NMTV and CET. As you know, for the past six years our fee for services has remained the same, which is something we are quite proud of. Under that fee arrangement this office is paid a monthly retainer of _____ which covers _____ hours of lawyer time per month calculated at a discounted rate of _____ per hour. All hours above _____ are billed at the reduced rate of _____ per hour. Disbursements and expenses are separately itemized. Over the past twelve months charges for fees have averaged approximately _____ per month (representing approximately _____ attorney hours, and _____ clerk hours per month), and disbursements have averaged approximately _____ per month.

I am now proposing that beginning with the next billing our agreement provide for a monthly retainer of _____ which will continue to cover the first _____ hours of lawyer time. These rates continue to represent a significant reduction of our current standard hourly rate of _____ per hour, and _____ per hour for clerk time. This, of course, says nothing about the tremendous increase in low power and other broadcast operations.
