





Dear Mr. Drush:

Following the various communications I have had with you and/or your representatives concerning Golden Valley Communications, Inc.'s (GVC) unbuilt construction permit for television channel 28, KCEO-TV, Oroville, California, this is to confirm that National Minority TV, Inc. (NMTV), a California non-profit which has directors in common with the Trinity Broadcasting Network, Inc., is interested in acquiring KCEO-TV subject to certain conditions. Accordingly, I am memorializing below NMTV's proposal concerning acquisition of KCEO:

- 1) In consideration for NMTV evaluating whether KCEO-TV's approved antenna/transmitter site can be moved in compliance with the FCC's short-spacing and technical rules so as to provide better coverage over Sacramento, California, GVC hereby grants NMTV an exclusive right to make an offer to purchase KCEO-TV, and no other negotiations, or consideration of any other purchase offers, will be entertained by GVC, while NMTV is making its evaluations.
- 2) NMTV must complete its engineering and technical evaluation concerning a site move for KCEO-TV, as noted in point 1 above, within ten (10) days after GVC accepts this proposal to make an offer, and if NMTV does not do so within that time GVC shall be free to continue negotiating or seeking purchase offers from any other party.
- 3) After the evaluation specified in point 1 above, in the event NMTV wishes to make an offer within the time period specified in point 2 above, said offer will be in compliance with FCC rule 73.3597 concerning the recouping of provable expenses.

- 4) Any agreement which might ultimately be reached between NMTV and GVC is subject to FCC approval based upon the submission of the necessary assignment of construction permit application.

I hope the foregoing is acceptable to you and GVC, and if it represents your understanding and intentions in this matter, would you kindly sign the enclosed copy of this letter and return it to me. Upon my receipt of your executed copy, the time period specified in point 2 above will begin and NMTV will expeditiously make its technical evaluation.

ARTICLES OF INCORPORATION
OF
TRANSLATOR T.V., INC.

ONE: The name of this corporaion is TRANSLATOR T.V., INC.

TWO: This corporation is a religious corporation and is not organized for the private gain of any person. It is organized under the Nonprofit Religious Corporation Law primarily for religious purposes.

THREE: The name and address in the State of California of this corporation's initial agent for service of process is:

PAUL CROUCH, 2442 Michelle Drive, Tustin, CA 92680.

FOUR: A. This corporation is organized and operated exclusively for religious purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code.

B. Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under Section 501(c)(3) of the Internal Revenue Code or (b) by a corporation contributions to which are deductible under Section 170(c)(2) of the Internal Revenue Code.

C. No substantial part of the activities of this corporation shall consist of carrying on propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate or intervene in any political campaign (including the publishing or distribution of statements) on behalf of any candidate for public office.

FIVE: The property of this corporation is irrevocably dedicated to religious or charitable purposes and no part of the net income or assets of this corporation shall ever inure to the benefit of any director, officer or member thereof or to the benefit of any private person. Upon the dissolution or winding up of the corporation, its assets remaining after payment, or provision for payment, of all debts and liabilities of this corporation shall

be distributed to a nonprofit fund, foundation or corporation which is organized and operated exclusively for religious or charitable purposes and which has established its tax exempt status under Section 501(c)(3) of the Internal Revenue Code.
