RE: Sale of KTD2-TV, Channel 24, Portland, Oregon Construction Permit (BPCT-5200, as modified)

Dear Mr. Vandaveer:

In accordance with your telephone conversations with Mrs. Jane Duff, the vice president/director of National Minority TV, Inc. (NMTV), which is affiliated with the Trinity Broadcasting Network, and owns KMLM, Odessa, Texas, this is to confirm that NMTV is interested in acquiring Greater Portland Broadcasting Corporation's (GPBC) referenced construction permit for channel 24, Portland, Oregon. Consequently, I have outlined below an agreement in principle, subject to negotiation and preparation of a definitive agreement and approval by both organizations' board of directors, concerning this matter:

- 1) NMTV will purchase GPBC's construction permit for channel 24 for a total consideration of \$500,000.00, or such less amount as may be approved by the Federal Communications Commission in accordance with the necessary assignment application. The total amount paid by NMTV will reimburse GPBC for its legal and engineering fees and disbursements generated during the preparation, filing, prosecution and partial construction of its channel 24 authorization. GPBC will be required to provide an itemization of such expenses in order to determine the amount it will receive, up to \$500,000.00.
- 2) The sale/assignment of channel 24 is contingent upon NMTV being able to obtain, prior to any closing and upon such terms and conditions as it may determine reasonable, the following: (a) full and unencumbered rights (including, but not limited to, all government and zoning authorizations and environmental clearances) to construct channel 24's antenna tower at the site approved by the FCC in its construction permit, or (b) a lease or other use agreement with the owners of the antenna tower now used by channel 49, KPDX-TV,


Portland, Oregon which will permit the construction of channel 24 at that site.

- 3) In the event NMTV is able to obtain a lease or use agreement for space on the antenna tower used by channel 49, KPDX, Portland, Oregon, as noted in point 2 above, it will pay GPBC, in addition to the ceiling amount specified in point 1 above, up to an additional \$5,000.00 to cover, either partially or fully, the cancellation and/or buy-out of GPBC's lease with the owners of Channel 24's present FCC approved antenna tower site.
- 4) This entire transaction is also subject to FCC approval based upon submission of the necessary assignment application (i.e., FCC Form 314).

I hope the foregoing is acceptable to you and GPBC, and if it represents GPBC's understanding and intentions in this matter, would you kindly sign the enclosed copy of this letter and return it to me. Upon receipt of GPBC's executed copy of this letter, the definitive contract can be drafted.

A FALLING AWAY FIRST...

"LET NO MAN DECEIVE YOU BY ANY MEANS: FOR THAT DAY SHALL NOT COME, EXCEPT THERE COME A FALLING AWAY FIRST, AND THAT MAN OF SIN BE REVEALED..." II Thessalonians 2:3

Who would have believed it? Who could have predicted it, that 1987 would witness the BEGINNING of this great FALLING AWAY! Of course, there has been apostasy or *falling away* in every generation, but who can deny the ominous polarization of humanity occurring all around us? Please understand, I am not just speaking of problems relating to recent scandalous revelations about *some* TV ministries, as reported in the secular press this year. Certainly these so-called "holy wars" have hurt and grieved the *true* Body of Christ more than anything in this generation. The impact on most Christian ministries has been devastating. Some churches are being forced to lay off staff members, and giving has plummeted *down 50%*. Even other areas, such as Christian books, literature and sacred music ministries, report income and activity off by *50% or more*. Since most of the controversy has centered around Christian ministries involved in the communications media you might expect the same problem *here*, and with a few exceptions, this is true. Thank God, TBN has been able to stay out of the conflict so that we have come through this tragedy largely untouched. I went to some lengths last month to explain that while our giving was *up* slightly, *our expenses*, because of so many new stations, *were up much more*. The net result is that even TBN is off in disposable income by almost *two million dollars*. *This means we will build 20 FEWER low and medium power stations than we COULD have!*

YES, THE COLD DARK FACTS ARE—THAT MANY HAVE FALLEN AWAY FROM SUPPORTING THE WORK OF GOD IN THIS CRITICAL TIME OF FINAL HARVEST!

Will the harvest still be reaped? Jesus said, "I will build my Church, and the gates of hell *shall not prevail*..." Praise God, the final victory of God's people is *not* in doubt, but I grieve for those who for whatever reason have been hurt and discouraged and have "*fallen away*." The reason I grieve for them is that they are in grave danger of *missing out* on the great promise of reward given by God to all who will "*endure to the end*." Not only will reward be *lost*, the greater danger is that some are in danger of "*strong delusion*" which Paul speaks of in II Thessalonians 2:12.

Make no mistake, the time is *HERE* when many will be deceived by satan himself! The reason I know that the time has begun is because the "*falling away*" *has begun*. Jesus warns of this time, that even some of the "*ELECT*" may be deceived!

But here is the frightening part: The time is coming when God himself will be so angry with those who "*fall away*" and with those who "*receive not the love of the truth*," that:

"FOR THIS CAUSE GOD SHALL SEND THEM STRONG DELUSION, THAT THEY SHOULD BELIEVE A LIE: THAT THEY ALL MIGHT BE DAMNED WHO BELIEVED NOT THE TRUTH."

II Thessalonians 2:11, 12

Only recently we witnessed *thousands* gathering on mountain tops around the world. They were opening up their minds to a so-called "HARMONIC CONVERGENCE"..."*away with the Cross, away with the preaching of the Gospel, away with the Church, AWAY WITH CHRISTIAN TELEVISION...*" Yes, away with *anything* telling them *what they do not want to hear!* "All is God and God is all," cry the NEW AGE generation. "We are GOD and we will bring in the new age for humanity!" Many have already "**BELIEVED THE LIE**" predicted by the Apostle Paul!

"Oh, I would never fall for that garbage," you cry, *but have you fallen for the lies in the secular press or from gossiping tongues that "ALL TV MINISTRIES ARE CROOKED?"* Have you stopped supporting your church or your ministry... Christian TV ministry or ANY work of God that you once supported?


