

Will the *GOOD NEWS* *never cease*? Praise the Lord — on March 14 (*Jan's Birthday*) we signed the agreement and deposited the down payment for *FULL POWER CHANNEL 61* serving the great Wilmington, Delaware — Philadelphia, Pennsylvania area! *Praise the Lord!* This will be, God willing, and the FCC approving, a *National Minority TV station* ( of which I am President ) working in full affiliation with *your TBN*.

A few weeks ago, Jan and I visited the station and were amazed at the vast region the station covers. The studio is in Philadelphia which means this is the *FIFTH largest TV market in the Nation!* — over *6.5 million souls* under the coverage pattern of the station. We also saw a region rich with American history. Two blocks down the street hangs the fabled *LIBERTY BELL*. A few more blocks and there it stands, The hallowed chambers of *CONSTITUTION HALL*.

In it our founding fathers signed our *DECLARATION OF INDEPENDENCE* on *July 4, 1776*. The Liberty Bell was rung to announce the *FIRST PUBLIC READING* of the *DECLARATION* —
