So Jan and I salute *you faithful partners* who have borne the heat of battle, who have held up our hands these past 15 years, who now rejoice with us as we see this great "NETWORK" mature into the powerful force God meant it to be – PRAISE THE LORD! YES, HAPPY BIRTHDAY TBN!

"AND INTO WHATSOEVER CITY YE ENTER...HEAL THE SICK, AND SAY UNTO THEM, THE KINGDOM OF GOD IS COME NIGH UNTO YOU." Luke 10:8, 9

How fitting as we celebrate our 15th year to announce that we have just entered *another* City! Praise the Lord! A medium power station, CHANNEL 36, NASHVILLE, TENNESSEE, is ON THE AIR! In prayer and meditation a few days ago it hit me – TOGETHER, WE ARE LITERALLY DOING WHAT JESUS COMMANDED US TO DO! Just as He commissioned the seventy (Luke 10) to go into all the towns and cities of His country, so He has sent *us* into our World and PRAISE GOD, we are GOING!


