PIERCE, FL; and KEY WEST, FL.** Full Power stations have been granted for **PORTLAND, OR and MIDLAND/ODESSA, TX.** Midland/Odessa will be **ON THE AIR in September!**

**BUT THERE'S MORE!** The tower is going up in **SAN SALVADOR, El Salvador, ST. LUCIA** (in the Southern Caribbean) is under construction and **HONDURAS** has been approved for the Capitol city, Tegucigalpa!


