WITHDRAWAL OF MOTION FOR LEAVE TO AMEND

Shellee F. Davis ("Davis"), by her attorney, hereby withdraws her "Motion for Leave to Amend" dated April 29, 1994. With respect thereto, the following is stated:

1. As indicated in the "Petition for Leave to Amend" filed by Wilburn Industries, Inc. on April 13, 1994, and the "Opposition and/or Motion to Strike Pleadings" filed by David A. Ringer on April 19, 1994, apparently on or about April 8, 1994, following the submission of Davis' amendment, the new owner of the site already designated by Davis in her original application stated that he had changed his mind and the site formerly used by WBBY-FM would no longer be available for use as the site of the FM station at issue in this proceeding. This information was first learned by Davis upon her counsel's receipt of Wilburn's Petition on April 15, 1994, and the status of the site subsequently was confirmed by Davis through direct contact

with Mr. Shumate (the new owner of the site) on April 27, 1994.




