The Lutheran Church-Missouri Synod (the "Lutheran Church") filed objections on March 30, 1994, to certain of the instructions and requests in the petitioners' (NAACP's) initial interrogatories. Subject to those objections, the Lutheran Church hereby answers the interrogatories as follows:

Please describe the corporate status of the Stations and the relationship of each Station to Respondent.

ANSWER

The Stations are not separately incorporated from the Lutheran Church but are assets owned and operated by the Lutheran Church.

INTERROGATORY THREE (3)

Please indicate the date KFUE-FM became a commercial station and describe any change in corporate structure this event necessitated.

ANSWER

For many years, the station operated non-commercially on a commercial frequency. In March 1983, the station made the decision to accept advertising. The action required no change in corporate structure in the Lutheran Church.

INTERROGATORY TWELVE (12)

Please identify each individual (including officers, directors, employees, or outside consultants or advisors, including counsel, to Respondent or the Stations) who is or was responsible for or otherwise involved in preparing any Form 395 or 396 data or any other EEO related documents, for maintaining, discarding or destroying Station EEO records, and for preparing, reviewing or approving all materials provided to the FCC in connection with the Stations' license renewal applications and the FCC's inquiries relative thereto, and state with reference to each such individual:

- (a) His name, title(s) and office(s) held, and inclusive dates served under each such titles or office;
- (b) His sex, race, color, religion and national origin;
- (c) All work and home addresses and work and home telephone numbers he is known to have used, including his last known work and home addresses and work and home telephone numbers; and




