JOINT MOTION FOR EXTENSION OF TIME

The Spanish American League Against Discrimination, Trinity Broadcasting of Florida, Inc., Trinity Broadcasting Network, National Minority TV, Inc., and Glendale Broadcasting Company respectfully move for an extension of time of ten days within which all parties may file their reply findings and conclusions.

This request is made at the initiative of SALAD. Its counsel has two D.C. Circuit briefs due three days before the current reply date, and reply findings in MM Docket No. 94-10 (Clayton, MO) due two days afterward. SALAD's counsel initially believed it would be physically possible to accommodate these commitments. However, he acknowledges that such optimism was premature in light of the over 1,150 pages of findings and conclusions filed in the case. SALAD is a public intervenor represented pro bono; thus, the task of distilling and concisely responding to this large volume of material will be especially difficult.


