OPPOSITION TO PROPOSED RULEMAKING

AND

PETITION FOR COUNTERPROPOSED RULEMAKING

Comes now, Goldrush Broadcasting, in pro per, to respectfully request that the Commission dismiss the proposed rulemakings at Chester and Shasta Lake City, California and accept this counterproposed rulemaking request. The petitioner requests that the Commissions' Rules be amended to allot the following FM channels and that Section 73.202(b) be amended to allot these channels to the following communities:

Chester, California	255C	255C, 259(A)
Shasta Lake City, CA.	NONE	296(C-3)
Alturas, California	267C, 293C	267C, 293C, 297(C)
Mc Cloud, California	NONE	276(C-3)

In support of this petition the following is submitted:

1. Through this counterproposed rulemaking request, Goldrush Broadcasting pleads that the Commission allot FM channel 259(A) to Chester, California instead of 296(A); 296(C-3) to Shasta

Lake City, California instead of channel 276(A); 297(C) to Alturas, California as that cities third WIDE AREA FM channel and FM channel 276(C-3) to the community of Mc Cloud, Siskiyou County, California as that communitys' first local FM channel.

2. Through this counterproposed rulemaking request, Goldrush Broadcasting states its willingness and ability to apply to the Commission for construction permits at both Alturas and Mc Cloud, California as well as Shasta Lake City, if the Commission allots the requested channels or channels of equal class to each of the requested communities.

3. The attached technical data to prove that the counter-proposed channels will comply with all of the Commisions' Rules and Regulations on allocations and allotment procedures is included as required. All required data to prove that this counterproposal is mutually exclusive is provided as well.

In conclusion, Goldrush Broadcasting requests that the Commission dismiss or amend the proposed rulemakings at Chester and Shasta Lake City, California and that the Commission accept the instant counterproposed rulemaking request to allot the requested FM channels to the communities of Alturas, Mc Cloud, Chester and Shasta Lake City, California. If allotted, Goldrush Broadcasting will apply to the Commission for use of the proposed channels.
