

("Lakeside") in the above-captioned proceeding. In support whereof, it is shown as follows:


Baum-Olson's Opposition to Lakeside's Petition would be due on January 3, 1995, pursuant to §§ 1.4(h) and 1.45(a) of the Rules. However, due to the intervening holidays and other prior business commitments, counsel primarily responsible for Baum-Olson's Opposition are unavailable until after the first of the year.
