MASS MEDIA BUREAU'S FURTHER PROGRESS REPORT

1. At a conference held in this proceeding on October 21, 1994, the Presiding Judge directed the Mass Media Bureau to submit a report identifying the steps taken to resolve this case. Tr. 43. On November 21, 1994, and December 22, 1994, the Bureau submitted progress reports to the Presiding Judge. The following is a further report on the progress made to resolve this proceeding.

2. The Bureau is considering the merits of an engineering proposal informally proffered by Santa Monica Community College District. If effectuated, the proposal would resolve the problems which have delayed resolution of this proceeding. Within the last two
