Dear Mr. Caton:

On April 19, 1995 Central Florida Educational Foundation, Inc. ("CFEF"), permittee of noncommercial educational station WEAZ, Union Park, Florida, filed a "Petition to Intervene/Petition for Remand" addressed to the Review Board and a "Petition for Reconsideration" addressed to the Honorable Joseph Chachkin (jointly referred to as the "Petitions"), both filed in connection with the above-referenced application.

CFEF's analysis and arguments contained in the Petitions were premised on the technical facilities specified in Community Educational Association's ("CEA") August, 1994 amendment to its application. Since CFEF filed its Petitions the applicant, CEA, has informed CFEF that CEA filed an amendment to its application, dated January 18, 1995, which altered CEA's proposed facilities. Significantly, this amendment has neither appeared in the Commission's BAPS system nor was a copy of the amendment available in the public file.

Upon review of the technical data included in CEA's last filed amendment CFEF has concluded that the objections raised in its Petitions have essentially been cured by the amendment.

Accordingly, CFEF wishes to withdraw both its "Petition to Intervene/Petition for Remand" and its "Petition for Reconsideration."

While CFEF's involvement in this application proceeding could have been avoided by accurate more accurate Commission files and data, the undersigned, as counsel for CFEF, apologizes for any
