SUPPLEMENT TO PETITION FOR
RULEMAKING

Hunt Broadcasting Co., Inc. ("Hunt"), by its attorneys, hereby supplements its May 2, 1995, Petition for Rulemaking and for Modification of Licenses ("Petition") in the above-captioned matter.

In the Petition, Hunt petitioned the Commission to modify Section 53.202(b) of the Rules, the FM Table of Allotments, to (i) substitute a higher class of channel for its station KDVE-FM, Denison-Sherman, Texas, (ii) modify the channel allotments on which stations KBUS-FM, Paris, Texas, MAD-FM, Madilla, Texas and KAIH-FM, Jacksboro, Texas to accommodate the KDVE-FM channel upgrade, and (iii) place a site-restriction on the KAIH-FM allotment, also to accommodate the KDVE-FM channel upgrade. Hunt stated that it was the proposed assignee of station KAIH-FM under an assignment application which was also filed May 2, 1995, and

thus that the requirement that a site restriction be imposed on KAIH-FM does not constitute an impediment to consideration and grant of the Petition.

Hunt is submitting herewith, as a supplement to the Petition, the Declaration of Albert L. Crain, the current licensee and proposed assignor of station KAIH-FM, in which he also states that he consents to the imposition of the site restriction upon the KAIH-FM allotment which is necessary to accommodate the KDVE-FM upgrade.



1. I am the permittee of station KAIH-FM, Jacksboro, Texas.

2. I consent to the imposition of a site restriction on the KAIH-FM allotment as proposed in the Petition for Rulemaking filed by Hunt Broadcasting Co. on May 2, 1995.
