

CONTRIBUTION and DISTRIBUTION NETWORKS




BROADCAST AUXILIARY SPECTRUM

2 GHZ SPECTRUM

- **120 MHz Spectrum
(1990 - 2110 MHz)**
- **Seven Channels**
- **Broadcasters and Cable Networks**
- **Increase 15% Per Year**

BROADCASTERS POSITION

- **Do not oppose FCC Proposal to Relocate ENG Channels 1 and 2 in Spectrum above ENG Channel 7, Provided that MSS Fully Underwrite Cost of Move**
- **Oppose Expedited Timetable or Changes to WARC-92 Global MSS Allocation in Upcoming WRC-95**

BROADCAST AUXILIARY SPECTRUM

MSS POSITION

- **Relocation of ENG Channels 1 and 2 in Spectrum above ENG Channel 7 is Cost-Prohibitive (\$3.2 billion)**
- **Reduce Amount of 2 GHz ENG Spectrum Available to Broadcasters**

BROADCAST AUXILIARY SPECTRUM

ISSUES

- **MSS Spectrum Needs**
- **WARC-95 Allocation for MSS**
- **Digital ENG Equipment**

BROADCAST AUXILIARY SPECTRUM

WHY 4 GHZ ?

- **Need Additional ENG Spectrum to Implement ATV**
- **Only Spectrum Wide Enough to Accommodate Video Transmission**
- **Contiguous to Spectrum Soon to be Transferred from Government -- Potential for Growth**

BROADCAST AUXILIARY SPECTRUM

FCC 4 GHZ PROPOSAL

- **Make spectrum available to different users, (wireless cable, ENG, aeronautical, etc.) under a newly-created broad service class**
- **Auction spectrum among different users**
- **Questionable legality**



BROADCAST AUXILIARY SPECTRUM

RECOMMENDATION

- **Defer Action on 2 GHz reallocation until after (a) WARC-95 and (b) Reliable Information on MSS's Real Spectrum Needs**
- **Defer Action or Postpone Implementation of Service Rules at 4 GHz in Docket 94-32 until FCC has Completed a Survey of ENG, MSS and other Competing Spectrum Needs**

Broadband PCS Band Plan





