COMMENTS

Hunt Broadcasting, Inc. ("Hunt"), Petitioner herein, by its attorneys and pursuant to Section 1.415 and 1.420 of the Commission's Rules, 47 C.F.R. §§ 1.415, 1.420, hereby submits its comments in support of the proposed amendments to Section 73.202(b) of the Rules, 47 C.F.R. § 73.202(b).

Hunt hereby incorporates by reference in these Comments its May 1, 1995 Petition for Rulemaking ("Petition") subject to the following information updating those comments. At the time the Petition was filed, Hunt had entered into an agreement to acquire by assignment the construction permit for station KAIH-FM, Jacksboro, Texas, one of the stations whose channel would be modified should the Petition be granted. The assignment of the KAIH-FM permit was consummated as of September 6, 1995. Hunt as permittee of KAIH-FM, consents to the modification of the KAIH-FM permit.

In its analysis of the Petition, the staff used different geographic coordinates for affected channel allotments than were utilized by Hunt's engineering consultant in preparing the engineering statement supporting the Petition. Hunt does not object to the coordinates used by the staff.

Hunt restates its intention and commitment to promptly file, upon grant of the Petition, an application for construction permit to modify the KDVE(FM) facilities to effectuate the channel modification proposed herein.

Hunt also commits and declares that it will reimburse the licensees of stations KBUS(FM) and KMAD(FM), respectively, for their reasonable and prudent expenses incurred in effectuating the channel reallocation, and will cooperate with said licenses in effecting the channel changes, all as required by the Commission's rules and policies.

For the reasons stated above and as set forth in the Petition, the public interest will be served by the upgrade of station KDVE(FM) to Class C1, and the modification of the allotments on which stations KAIH(FM), KBUS(FM) and KMAD(FM) operate. Accordingly, the Commission should grant the Petition and modify the FM Table of Allotments, Section 73.202(b) of the Rules, as Hunt has proposed herein.
