REPLY COMMENTS

Salem-Teikyo University, by its attorneys, pursuant to Notice of Proposed Rule Making, DA 95-1534, released July 26, 1995, which specified October 3, 1995 as the date for the filing of reply comments, submits the following:

1. On or before the comment date in this proceeding, only Salem-Teikyo University and Seven Ranges Radio Company, Inc. filed comments. Salem-Teikyo University on September 18, 1995 reaffirmed its continuing interest in the allotment of a Class A channel to Salem, West Virginia. Seven Ranges Radio Company, Inc. on August 19, 1995 counterproposed the allotment of Channel 258A to New Martinsville, West Virginia, and proposed the allotment of Channel 277A to Salem, West Virginia.

2. Salem-Teikyo University's interest is in the allotment of a new Class A channel to Salem, West Virginia. It appears that interest may be accommodated by the allotment of Channel 277A to Salem, West Virginia while accommodating the request of Seven Ranges Radio Company, Inc. for the allotment of Channel 258A to New Martinsville, West Virginia. Accordingly, the Commission should move forward with the allotment of Channel 277A


