

Two copies of this Notice are being submitted to the Secretary of the FCC in accordance with Section 1.1206(a)(1) of the Commission's rules.





LATAs With Interstate IntraLATA Calling Are Special Cases

Suggested Action Items

Toll Free NPRM (91-281)

- **Support inclusion of 888 Branding/Vanity Number Protection limited to no more than 5% per RespOrg.**
- **Require each RespOrg to manage selection process for 888 Branding with their own customers.**
- **Limited reservations for 888 to no more than 8% of RespOrgs working numbers.**

Caller ID (91-281)

- **Encourage Common Carrier Bureau to continue urging RBOC compliance with intent of Recon Order.**
- **All LECs (including RBOCs) must make CPN available to IXCs immediately at wholesale, cost-based rates. CPN passage should apply equally to IXCs and LECs.**
- **Support for a proposed petition to clarify Recon Order.**

Exception Areas (92-237)

- **Take action to either associate Exception Areas calling [interstate intraLATA toll] with intrastate PICs where customer choice exists or with all other interstate calling.**
- **Allowing customer choice for all interstate calling -- include exception areas -- would realize the goal of customer choice most quickly.**

Recent Responses to AT&T Request for CPN Resale

AMERITECH: 10-17-95

"...we currently do not offer any interstate CPN-based services. Let me assure you that we will advise AT&T as soon as practical should Ameritech offer interstate CPN based services in the future."

BELLSOUTH: 10-16-95

"...concerning a date on which we will begin wholesale provisioning of CPN...while we have no specific date established, I am hopeful that our current discussions concerning resale will result in an agreement that will include a variety of services."

CINCINNATI BELL: 10-31-95

"...we believe that the FCC's order presents a conceptual position, as opposed to a directive, for the resale of interstate CPN-based services"

NEVADA BELL: 11-3-95

"Nevada Bell will move towards offering resale tariffs for those features that can be offered under mutually beneficial terms for both of our companies."

NYNEX: 11-13-95

"Peter indicated...that at the current time we did not have a date scheduled to begin wholesaled provisioning of CPN based services and that we would advise AT&T when a date was available."

SOUTHWESTERN BELL: 10-17-95

"At the present time, SWBT is continuing to evaluate the wholesale/resale of local exchange vertical services and the issues surrounding this change in business operations."

SPRINT: 10-11-95

"...our differing positions regarding the wholesaling of these services will be resolved in the regulatory and legislative arena but this should not prevent us from working through implementation processes now."

US WEST:

"Currently, US West Communications does not have any interstate CPN-based services. Let me assure you that we will advise AT&T as soon as practical should US West offer interstate CPN-based services in the future."
