Dear Mr. Caton:

In the above-referenced Petition for Rulemaking ("Petition"), Motorola Satellite Communications, Inc. ("Motorola Satellite") proposes: (i) reallocating the 37.5-38.6 GHz band to Fixed-Satellite Service ("FSS") downlinks; and (ii) adopting certain ITU Radio Regulation power flux density ("PFD") limits for the 37.5-40.0 GHz band. Pursuant to Section 1.405 of the Commission's Rules,¹ Alcatel Network Systems, Inc. ("ANS"),² by its attorney, hereby opposes grant of the Petition.

In an Opposition to Petition for Rulemaking filed concurrently herewith ("Opposition"), the Fixed Point-to-Point Communications Section, Network Equipment Division of the Telecommunications Industry Association ("TIA"), demonstrates that Motorola Satellite's proposals are premature, without merit, and therefore must be denied. TIA bases this opposition on the fact that: (i) Motorola Satellite has failed to demonstrate any need for the proposed reallocation; (ii) the reallocation would continue an unacceptable
