Pursuant to Section 1.1206 of the Commission's Rules, 47 C.F.R. § 1.1206, we submit the following information for inclusion in the public record of the non-restricted notice and comment rulemaking proceedings in the above-referenced dockets.

On September 17, 1996, the Commission sponsored an "Enforcement Forum" with representatives of various State Public Utility Commissions to discuss enforcement issues raised by the Telecommunications Act of 1996 ("the 1996 Act"). In lengthy discussions, covering a broad range of topics relevant to this subject, the participants touched on the ongoing rulemaking proceedings in the dockets captioned above.

Several of the state representatives expressed concern about the active role outlined for the FCC in the report and order in FCC 96-325 and its component dockets with respect to state arbitration of interconnection agreements pursuant to sections 251 and 252 of the 1996 Act. As to CC Docket 94-129, several state representatives noted that they are encouraged by

the actions the FCC has taken to prevent unauthorized conversions in subscriber carrier selections and urged the Commission to do more.

A list of the names of Commission staff and representatives of the State Utility Commissions attending the Enforcement Forum is attached.
